EXECUTIVE SUMMARY

The Asian Development Bank (ADB), Agence Française de Développement (AFD) and Government of Bangladesh (GOB) supported Improving Urban Governance and Infrastructure Program (IUGIP) under the results-based lending (RBL) modality which aim to improve infrastructure facilities such as drains, roads, streetlights, low-income neighborhoods improvements (footpaths, drains, streetlights, tube wells, dust bins and community toilets), and market centers and parks in selected 88 pourashavas. ADB has supported enhancements in pourashavas' service delivery capacity and effectiveness through a series of sector projects to reduce regional disparities and encourage local economic development: the Urban Governance and Infrastructure Improvement Project (UGIIP) in 2002, the second UGIIP (2008), and the third UGIIP (2014).

Under IUGIP, out of 88 Pourashavas, 63 are classified by LGED as 'mainstream pourashavas' and 25 are under Operation and Maintenance (O&M). A total of 63 Pourashavas were selected for improvement of infrastructure facilities such as construction and improvement work of drains, roads, streetlights, low-income neighborhoods improvements (footpaths, drains, streetlights, tube wells, dust bins and community toilets), market centers and parks under IUGIP. These pourashavas were not selected before for Urban Governance Infrastructure Improvement Projects (UGIIP-I, UGIIP-II and UGIIP-III) of LGED. LGED has been considering these pourashavas as mainstream pourashavas. To keep up the continuation of the solid waste management works (SWM) at the pourashava level, the completed sub-projects related to SWM under UGIIP-III further required operation and maintenance (O&M). A total of 25 Pourashavas of this type are included in IUGIP and these Pourashavas are considered for O & M interventions. The project has taken a holistic and integrated approach to urban development under the results lending modality. IUGIP is being implemented by Local Government Engineering Department (LGED) under the Ministry of Local Government, Rural Development and Cooperatives (MLGRDC). LGED is the Executing Agency and Pourashavas are the implementing agencies of the Program. IUGIP will follow the Environment and Social Management Framework (ESMF) aligned with the National Laws and ADB safeguards policy principles for Involuntary Resettlement and Indigenous Peoples/Tribes, Minor races, Ethnic Sects and Communities (TMRESC). IUGIP became effective on 12 October 2023. Consultants were hired by the PMU through PMDSC with approval from ADB who started their responsibilities and activities since January 2024. This 3rd Semiannual Social Safeguard Monitoring Report (SSMR) provides an overview of the IUGIP compliance status against the applicable standards of Bangladesh laws and regulations, and Social Safeguard standards as per ADB SPS for the period of October 2024 to March 2025. Social screening of the subprojects was undertaken using the involuntary resettlement screening checklist (Appendix 4, ESMF). A separate screening checklist has been prepared for TMRESC impact screening.

The first SSMR (Oct 2023–Mar 2024) and was submitted to ADB and disclosed on both the ADB and IUGIP websites. The second SSMR (Apr–Sept 2024) has likewise been submitted for ADB's review. A Program Safeguard System Assessment (PSSA) was conducted and reported on March 2023. During preparation of PSSA, due diligence was conducted in five sample Pourashavas to examine RBL program activities. The objectives of the PSSA were to identify potential safeguard impacts and risks and to assess the program systems. The PSSA assessed the existing laws, regulations, rules and guidelines for managing and mitigation of environment and social impacts of the RBL program. The PSSA identified gaps between ADB safeguard Policy Principles and program safeguard systems and recommended programs actions to improve program safeguards and the safeguard action plans.

IUGIP has prepared an Environment and Social Management Framework (ESMF) and submitted it to ADB. The ESMF has been disclosed on the ADB and IUGIP websites. The key objective of the ESMF is to establish clear procedures and methodologies for environmental and social planning, review, approval and implementation of components to be financed under

this Program. The monitoring activities of social safeguard team include implementation of the ESMF especially for involuntary resettlement and TMRESC/indigenous peoples' safeguard.

IUGIP prepared guidelines following SPS 2009 and the approved ESMF for consultation with TMRESCs. The consultation guideline is designed to help to ensure that indigenous/TMRESC peoples are well informed, consulted and mobilized to participate in the project works to be implemented under the IUGIP. Their participation will not only make project activities more sustainable but also provide benefits with more certainty or protect them from any potential adverse impacts of project intervention. The main features/process of the consultation framework includes a social impact assessment to determine the degree and nature of impact supported by the project. (Para 37 to para 41).

The program spans across eight administrative divisions in Bangladesh, with the project *pourashavas* located in each of these divisions. The Social Safeguard Team of PMDSC consists of Resettlement/ Social Safeguard Specialist and four Junior Resettlement/Social Safeguard Specialists. The program spans across eight administrative divisions in Bangladesh, with the project *pourashavas* located in each of these divisions. Each Junior Resettlement/ Social Safeguard Specialists is responsible for assessing social safeguard impacts and monitoring of social safeguard activities related to program works in two Divisions under the coordination of Resettlement/ Social Safeguard Specialist. The Resettlement/ Social Safeguard Specialist oversees the performance of four Junior Resettlement/ Social Safeguard Specialists, ensure social safeguards compliance at *pourashavas*/field-level, prepares various periodical social safeguard monitoring reports and implements resettlement plan/ DDRs. Additionally, a Senior Assistant Engineer from PMU serves as the focal person for Resettlement/ Social Safeguard issues.

During the reporting period October 2024 – March 2025, the social safeguard team MDSC consultant visited 43 packages in 24 *Pourashavas* for social screening and monitoring. The list of the packages screened by social safeguard team is provided in Appendix 1. Out of the listed 166 packages, 119 were visited during Project Preparatory Technical Assistance (PPTA) period and 47 by the MDSC consultants. The MDSC assessed packages are marked with star mark (*) in the list. The team used the 'Involuntary Resettlement Screening Checklist' (Appendix-4) from the ESMF to identify potential involuntary resettlement impacts and risks. Social safeguard impacts were assessed based on physical observations of the schemes, discussions with community members during public consultations, and interactions with stakeholders, community leaders, and other stakeholders. If the screening identifies involuntary resettlement impacts, LGED will prepare a resettlement plan. For those without involuntary resettlement impacts, due diligence Reports (DDR) will be prepared. During the impact assessments from October 2024 to March 2025, the social safeguard team conducted 43 public consultations, involving a total of 723 participants, of which 585 were male and 138 were female.

Due Diligence Reports (DDR) were prepared following the assessment of subprojects by the Social Safeguard Teams. Draft copies of the DDRs are submitted to PMU through Team Leader, PMDSC. The focal person of social safeguard designated from PMU then reviews the DDR and takes necessary action. During the reporting period, the Resettlement Team submitted 23 DDRs by screening 23 packages under 19 *pourashavas* (Table 6). Up to March 2025, a total of 45 DDRs have been submitted to PMU by PMDSC consultants. A total of 156 DDRs (111 at PPTA period + 45 by PMDSC) are disclosed on the IUGIP Website. Package number IUGIP/TUNG/UT+DR-1 has been cancelled as the existing infrastructure has been constructed only few years before. The package components may be considered for improvement if it is needed in future.

IUGIP established the grievance redress mechanism (GRM) to voice and resolve social and environmental concerns linked to the project and ensure greater accountability of the project

authorities towards all affected persons The GRM addressed aggrieved persons concerns and complaints promptly using an understandable and transparent process that is gender responsive, culturally appropriate, and readily accessible to all segments of the affected people at no costs and without retribution. A guideline to operate GRM already prepared in Bengali and are mailed to all Pourashavas through PMU in August 2024. The GRCs in 10 Pourashavas received 47 complaints during the reporting period and resolved 46 complaints. A complaint remains unresolved at Gangni pourashava. The complainant of Gangni Pourashava stated in his complaint that few people are disrupting the construction of the park for their personal interest, causing delays in project's progress. The complainant has requested to complete the construction of the park as early as possible. The local people and the local administration are currently engaging with the complainants to resolve the complaint.

Capacity building training on environmental and social safeguard policies have been arranged by PMU. The training programs are being conducted at LGED Regional Training Centers (RTC), PIUs and subproject construction sites. The safeguard planning and monitoring instruments will also be discussed in the training program. A guideline on capacity-building/training for safeguard compliance is outlined in the ESMF (Para 149 & 151). The preparation of the training manual for training on social and environmental safeguard and climate change is under process.

Training courses on gender, environmental and social safeguard, contract management, climate change and quality control of Infrastructure for Contractors and Project Pourashava Engineers is part of the overall training courses. These training programs are designed and implemented with the aim to capacitate the PMU and PIUs of the program. IUGIP arranged two Capacity Building Trainings for Safeguards at two Regional Training Cewnters of LGED. A total of 60 participants from 20 Pourashavas, MDSC and IUGIP staffs working at pourashavas participated in the training program. ADB policy on social and environmental safeguards and on climate change was discussed in the training programs.

During the reporting period, the Asian Development Bank (ADB) had one Loan Review Missions for IUGIP from December 11 to 17, 2024 to review the progress, compliance, and the diligence of the ongoing works and services. The mission met the relevant stakeholders including the project management unit (PMU) of IUGIP, selected implementing agencies (pourashavas), contractors, consultants and communities.

I. INTRODUCTION

A. Project Background

1. The Asian Development Bank (ADB), Agence Française de Développement (AFD) and Government of Bangladesh (GOB) supported Improving Urban Governance and Infrastructure Program (IUGIP) under the results-based lending (RBL) modality which aim to improve infrastructure facilities such as drains, roads, streetlights, low-income neighborhoods improvements (footpaths, drains, streetlights, tube wells, dust bins and community toilets), and market centers and parks in selected 88 pourashavas. ADB has supported enhancements in pourashavas' service delivery capacity and effectiveness through a series of sector projects to reduce regional disparities and encourage local economic development: the Urban Governance and Infrastructure Improvement Project (UGIIP) in 2002, the second UGIIP (2008), and the third UGIIP (2014).

2. The RBL program's impacts will be: reduce of urban poverty and improvement of living conditions.

3. The outcome will be: improved municipal services and governance in target pourashavas in terms of increased holding tax collection efficiency (DLI 1) and improved livability (non-DLI). Selected DLIs, identified under each output described below, will create incentives to achieve the program's expected outcome. The program includes the following outputs: Output 1: Institutional capacity for inclusive municipal governance strengthened; and Output 2: Municipal infrastructure improved in quality, access, resilience, and gender responsiveness.

4. The following are the disbursement-linked indicators output-wise:

5. This Semiannual Social Safeguard Monitoring Report provides an overview of the Improving Urban Governance and Infrastructure Program (IUGIP) compliance status against the applicable standards, laws and regulations for Social Safeguard for the period of October 2024 to March 2025. An Environment and Social Management Framework (ESMF) has been prepared for IUGIP and ADB approved the ESMF. This guiding framework is prepared to ensure that subsequent project activities have a common understanding of the environmental

and social issues involved, and a harmonized approach to handling these issues is followed. The ESMF is being used as guidelines to address the safeguard compliances throughout the project area. This social safeguard monitoring report (SSMR) includes the activities during monitoring of implementation ESMF, specifically for involuntary resettlement and Tribes, Minor Races, Ethnic Sects and Communities (TMRESC) safeguards. This SSMR has been finalized based on the site visits under different packages of Pourashavas, it includes discussion with the stakeholders and community people.

B. Objectives of this SSMR

6. As a result-based loan, LGED has to ensure that environmental and social impacts are adequately addressed. The main objective of social monitoring is to: (i) provide an assessment on the progress of social safeguard compliances of the program during the reporting period. This SSMR (ii) provides update/status on the implementation of the ESMF and the safeguards policy action. The key safeguards implementation plans will be the social safeguards documents prepared for the subprojects where involuntary resettlement impacts are triggered; (iii) verifies subproject's compliance with social safeguards measures and its progress; (iv) documents any issues and concerns in the covered period; and (v) recommend/come up with follow up action to ensure social safeguards compliance.

C. Scope of the SSMR

7. Social safeguard monitoring is an integral component under RBL program. The program will follow the procedures and requirements provided in the Environmental and Social Management Framework (ESMF). At the PMU level, the Social Safeguard Team has developed a methodology following the guidelines of ESMF and appendix 5 of PID for social safeguards monitoring. The social safeguard experts have been verifying the safeguard compliances with the safeguard measures and its progress toward intended outcomes.

8. Social Monitoring Checklists has been used to know how the social safeguard compliances are addressed during construction period. It is also to measure the progress/achievement of the indicators from the baseline data generated by the due diligence and social screening exercises at the subproject level. These indicators are essential for monitoring compliance with safeguards during project implementation, with a particular emphasis on involuntary resettlement and TMRESC safeguards. PMDSC consolidates the progress reports and accordingly, prepared this SSMR for the RBL program.

9. The 3rd Semi-annual Social Safeguard Monitoring Report is prepared for the reporting period October 2024 to March 2025. The program was approved on 13 July of 2023, and the loan became effective on 12 October 2023. The 1st SSMR was prepared for the period of October 2023 to March 2024. ADB and IUGIP disclosed the 1st SSMR on their own website. The 2nd SMR was prepared for the period of April to September 2024 and submitted to ADB for their concurrence.

D. Objective of this SSMR

10. The aims to:

- (i) Establish and maintain procedures to monitor the progress of implementation of safeguard policies/ plans;
- (ii) Capture any adverse impact in terms of involuntary resettlement impact (income loss due to loss of access during construction, structure loss, etc.) or TMRESC-related impacts during construction works.
- (iii) Provide information on necessary safeguard methods adopted to avoid, reduce, minimize, mitigate or compensate any adverse impact due to project work.
- (iv) Identify mitigation measures and any residual negative impacts that cannot be avoided,
- (v) Describe process undertaken during project design and to disclose project activities to stakeholders and beneficiaries of the subproject.
- (vi) Describe the subprojects Grievance Redress Mechanism for resolving complaints and its resolution.
- (vii) Monitor and provide recommendation and other follow up actions to ensure progress toward the desired outcome.

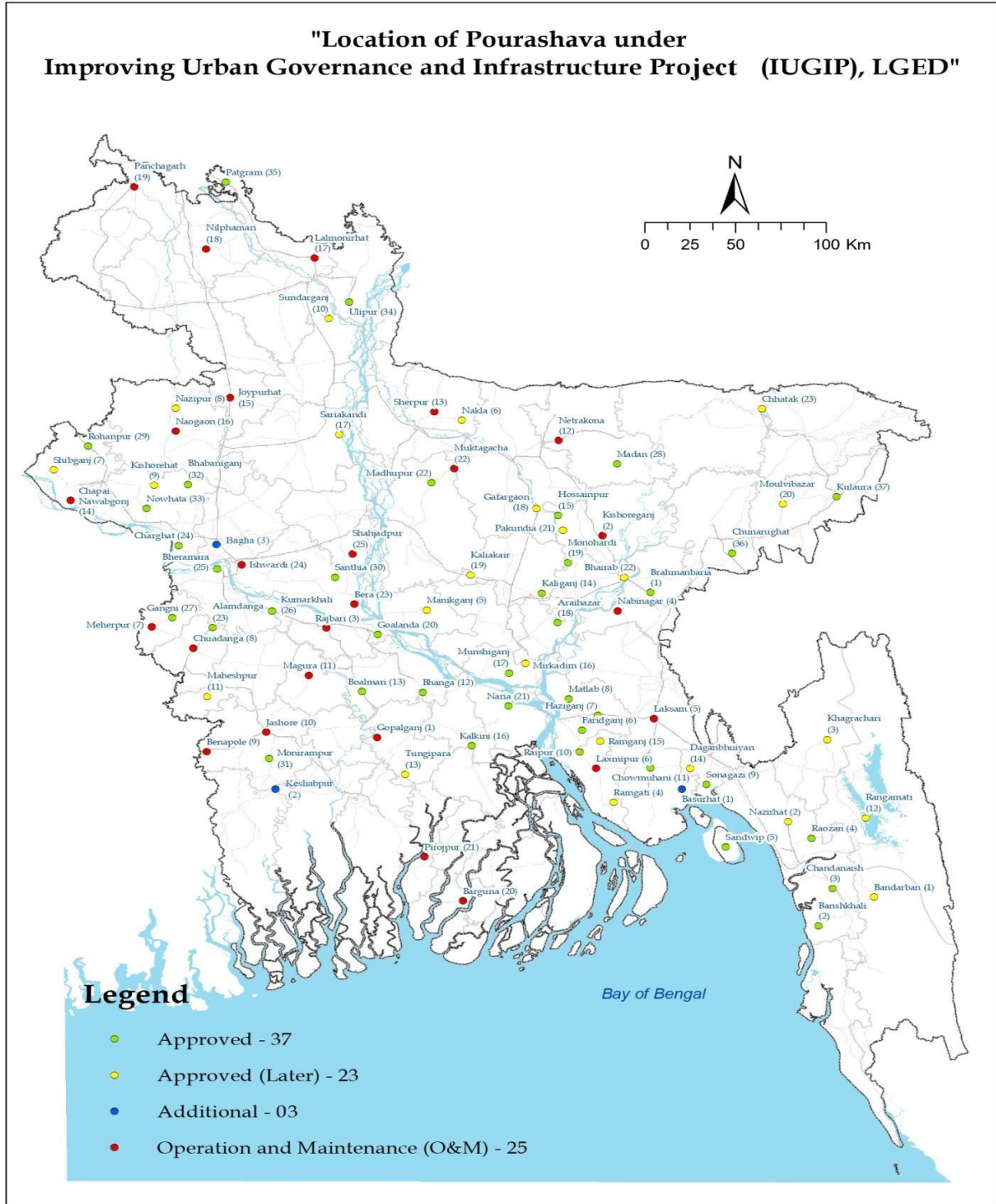

II. SOCIAL SAFEGUARD IMPACT ASSESSMENT

12. During the reporting period, the social safeguard team visited 43 packages across 24 Pourashavas for social screening and for monitoring ongoing subproject sites. The consultants screened the social safeguard impacts at the subproject areas. The screening and social assessment process was carried in each scheme using the involuntary resettlement screening checklist provided in the Appendix 4 of the ESMF. Requirement of preparation of RP or DDR is determined by social screening process.

A. Involuntary Resettlement Safeguards

13. During social screening and due diligence, potential impacts are found mainly related to construction and are short term, localized and can be mitigated with effective construction practices and measures. Roads, footpaths and drain works will be carried out along the existing road rights of way within the government lands. Hence, no additional land and no involuntary resettlement impact will be required. While the overall program is classified as category B for involuntary resettlement safeguards, the pourashavas that have been screened did not have impacts related to land acquisition and involuntary resettlement impacts. Packages that have been awarded are not assessed to have private land acquisition and involuntary resettlement impacts. Hence, due diligence reports were prepared. If any unanticipated impacts identified during construction involving income loss or displacement, a Resettlement Plan will be prepared instead of Due Diligence Report.

14. Throughout the implementation period, if any unanticipated resettlement impacts are observed, necessary mitigation measures will be taken to avoid or mitigate the impacts. Therefore, any potential impact of the subprojects will be fully avoided, and correspondingly, no issues relating to involuntary resettlement will occur during implementation of the subproject. Although, these roads and drainage schemes will not have any involuntary resettlement impact but, the construction/improvement of the subproject may cause only minor and temporary disturbances limited to dust and noise, movement of people etc., which are limited to the construction period only, and could easily be mitigated. Damages/unanticipated losses caused due to construction works will be eligible for compensation following ESMF (Para 22 and Entitlement Matrix at Appendix 12 of ESMF).

15. In case of involuntary resettlement and TMRESC impacts are assessed, the program will prepare resettlement plan and TMRESC Plan following the policy principles outlined in ESMF.

B. Tribes, Minor Races, Ethnic Sects and Communities (TMRESC)

16. The program is classified to be category B for indigenous people/ Tribes, Minor Races, Ethnic Sects and Communities (TMRESC). However, the TMRESC population is scattered around the Pourashavas in almost all the Pourashavas and are well assimilated in the urban society. As per the PSSA (para 6 and 24), among the project pourashavas, only Banskali and Naohata have TMRESC populations that exceed 1%. As per the PSSA, it is expected that the RBL program will have beneficial impact on the TMRESC in these two *pourashavas*. DDRs prepared for these Pourashavas will include a specific action plan in accordance with the policy principles outlined in the ESMF. However, in Banskali, based on the recent field visit and consultation, the data in the census is not updated, and that based on the findings of the recent field visit and consultation, the individuals bearing the surname Barua residing in Banskali Pourashava, particularly in Baruapara, are not members of any officially recognized ethnic minority groups in Bangladesh. Please refer to the detailed discussion in the consultation section.

17. Bangladesh is a country of cultural and ethnic diversity, with over 54 Indigenous/TMRESC Peoples speaking at least 35 languages, along with the majority Bengali population. According to the 2022 census, the country's TMRESC population numbers approximately 1,650,478 which represents 1% of the total population. Chakma, Garo, Manipuri, Marma, Munda, Oraon, Santal, Khasi, Kuki, Tripura, Mro, Hajong and Rakhain are some of the well-known TMRESC communities in Bangladesh. TMRESC people in Bangladesh call themselves 'Adivasi'.

18. The following table shows the TMRESC population in Bangladesh by Divisions. Table 3 presents the distribution of TMRESC population by Division in Bangladesh. The Pourashavas under the IUGIP are located across all eight Divisions of Bangladesh.

19. The table describes the total TMRESC population and percentage by Division. It has been revealed from the table that out of the total population in Bangladesh, the TMRESC accounts for 1%. Out of the eight Divisions, TMRESC population is less than 1% in five Divisions and slightly higher in two Division. The highest percentage (2.99%) of TMRESC people are living in Chattogram Division. The program PSSA describes that out of 88 Pourashavas, 37 Pourashavas under the RBL program have TMRESC constituting less than 1% of total population. However, in two Pourashavas, Bankshali and Naohata, the TMRESC population accounts for 3.91% and 1.57%, respectively. The ratio nearly equal with males comprising of 1.01% and females 0.99% respectively in terms of gender distribution.

20. It has been reported in the Bangladesh Census Report of 2011² that there are 1,444 ethnic people in 284 households at Ward number 5 and 6 of Banskhal Pourashava. Upazila-wise summary findings are shown in Chapter 3 of the Community Report of the Census of 2011. The summary findings of Banskhal Upazila (3.3) describes in Para No. 3.3.3 (Administrative/Geographic Unit) that there are 9 wards and an average 4101 people live in each ward. According to the summary findings of Bangladesh Census Report of 2011, 'ethnic' people at Banskhal pourashava is 3.91% of total population of pourashava.

21. **Banskhal TMRESC issues:** During the last reporting period (September 22 to 24 of 2024), the Resettlement/Social Safeguard Specialist of IUGIP visited Banskhal Pourashava. During the visit, the team has monitored different program activities. The Resettlement Specialist met with Municipal Executive Officer, Birth Registration Officer of Municipality, talked with Ward Counselor of Ward No. 4, 5 and 6 of the Banskhal Pourashava, met with local Journalists (Daily Azadi, General Secretary- Banskhal Press Club, Editor – Azker Banskhal), Executive Member of Upazila Shilpakala Academy, two NGOs and talked with General Secretary of Banskhal Buddhist Association, participants of public consultation to collect information about TMRESC Communities in Banskhal. All of the sources reported that number of TMRESC people at Banskhal Pourashava is significantly less than 1% and no TMRESC people will be affected due to IUGIP works at Banskhal.

22. **Naohata TMRESC issues:** The Resettlement Specialist and one of the Jr. Resettlement Specialists of PMDSC, IUGIP paid a visit to Naohata and Bhabanigonj Pourashava of Rajshahi District from November 17 to 21, 2024 to monitor social safeguard issues at IUGIP sub-projects in the Pourashavas. The visiting Resettlement and social safeguard team visited the only TMRESC group living at Naohata. Eleven (11) Santal (tribes) households live in an unused place owned by Bangladesh Water Development Board. The 11 households consist of fifty Santal people. These Santal people are the only TMRESC group living in this pourashava. The Birth Registration officer of the pourashava reported that there are no TMRESC group other than this group living in the pourashava. During consultation with the Santals of Duari Adivasipara and other places of Naohata Pourashava, it had been reported that there are no TMRESC peoples group in Naohata pourashava other than the Santal groups living at Adivasipara. Somehow, there may be a few TMRESC people live in the pourashava. In that case, they are so small in number, live temporarily and live so scatteredly that it is very difficult to identify them.

23. A Specific Action plan for TMRESC/ Santal group lives at Duari Adivasi Para of Naohata has been prepared and appended as Appendix 4.

24. The following social safeguards-related program actions agreed with ADB are provided in the Program Implementation Document to monitoring the social safeguards compliances and strengthen the capacity of LGED to implement the RBL program.

D. Program safeguards Systems Assessment (PSSA)

25. A Program Safeguard Systems Assessment (PSSA) was conducted for the program. During this stage, due diligence was done in five program towns (Chowmohani, Rouzan, Araihasar, Naohata and Keshabpur) based on ESMF. During the assessment (PPTA period-2022), the team physically visited the Pourashavas and no IR potential impacts of project construction works related to involuntary resettlement was identified and DDRs were submitted. During that time, several stakeholder consultation meetings were conducted with the Mayors, Pannel Mayors, Pourashava Councilors and Secretaries, TLCC and WC Members, concerned Engineers and Officials of the Pourashavas. Public consultations in these Pourashavas were also conducted to exchange views with the beneficiaries of the program, to disclose project objectives and activities and also to assess the potential impacts of the program.

E. Public Consultation

26. Public consultations with the community people at different subprojects of Pourashavas were undertaken to exchange views on subproject implementation and to disclose project activities. The public consultations are conducted with prior notice, ensuring wide reach and accessibility for individuals from various sectors. At project implementing unit, (PIU), contractors with the supervision of the Pourashavas are implementing construction works of road, drain and streetlight under different schemes. Participants of these consultations are community people, Pourashava officials, Councilors, TLCC, WC members, People's Representatives, contractors or their representatives, local leaders, businessmen, religious leaders, journalists, other government officials and different stakeholders since subproject preparation to date who participated at different stages of the program activities. The consultations/meetings were conducted at subproject sites and Pourashava offices. In addition, hotspot/information discussion were held in the project site as a part of information dissemination about the upcoming subproject.

27. The following topics were discussed in the public consultations. The topics are summarized as follows:

- (i) Briefing on program background and objectives
- (ii) Background of subproject selection and scope of the construction works.
- (iii) Potential benefits from the subproject expected by the program.

- (iv) Potential problems and its magnitude that may occur during construction, its avoidance or mitigation to be undertaken by the PIU and contractors.
- (v) Program policy on social safeguard, responsibility of PMU, PIU and contractors to comply with the social safeguards requirements.
- (vi) Project Grievance Redress Mechanism in details was discussed. The focal person of GRC in PIU, contractors' responsibility in GRM, and process of grievance hearing was discussed.
- (vii) Copy of Grievance Registration Form was provided.
- (viii) Suggestions from the beneficiaries for the betterment of the subproject was sought.
- (ix) Up to the reporting period for ongoing subprojects no IR impacts identified. In case, any of the subprojects require land for acquisition/ negotiation, in that case what will be the project compensation policy and negotiation policy it was discussed in the consultations.
- (x) Responsibility of beneficiaries in the maintenance of the subproject discussed

28. Details on consultation/meetings are described in the following paragraph and in Table No. 4. IUGIP arranged 43 public consultations in 24 Pourashavas during the reporting period. A total of 723 participants (male- 585 and female- 138) participated in the meetings. The major objective of such consultations was to exchange views on project objectives and activities, assessing potential impacts of project activities and to disclose project mitigation plan of potential adverse impacts as per ADB SPS. In these meetings, different issues related to project activities, problems/constraints and project methods to address the constraints are identified and discussed. Consultation is a continuous process which requires holding meetings with the project beneficiaries from the very beginning of the project preparation to the stages of implementation and monitoring of the project activities. The Grievance Redress Mechanism of the project has been discussed in these meetings. Formation of grievance redress committees (GRCs), GRC functions, types of complaints, procedures of submitting complaints, different stages of GRM etc. were discussed at the meetings. Feedback from the participants is recorded and facilitators (Resettlement Team) responded on the concerns of participants. List of public consultations held during the reporting period are presented in the following table and concerns raised by the participants are discussed in the following paragraph. The community people, local leaders, project beneficiaries along with subprojects and other stakeholders attended the public consultation. This interactive approach will continue during the implementation of the subproject. The findings of the above consultations revealed lots of positive impacts in spite of a few temporary impacts/concerns limited to construction period only, which have the scope of mitigation.

F. Consultation with the TMRESCs

29. **TMRESC consultation at Naohata:** The Resettlement Specialist and one of the Jr. Resettlement Specialists of PMDSC, IUGIP paid a visit to Naohata and Bhabanigonj Pourashava of Rajshahi District from November 17 to 21, 2024 to monitor social safeguard issues at IUGIP subprojects in the Pourashavas. The visiting Resettlement and social safeguard team visited the only tribal group living at Naohata. Eleven Santal (tribes) households live in an unused place of Bangladesh Water Development Board. The eleven households consist of fifty Santal people. Santal families are patriarchal. No household from

mainstream population live here. The Santals came from different places as agricultural day labor and settled here for last seven to eight years. All of the adult persons of these eleven households are agriculture day labor. Both the male and female members of this community work in the field. All of them found literate and they can read and write Bengali. IUGIP has LINIC (Low-income Neighborhood improvement Committee) program for this tribal group. Currently, it is the harvesting period, and the Santal people are busy on harvesting works. Hence, the consultation meeting with these TMRESC people was arranged at evening of November 18, 2024. As it was dark, electric light was insufficient and there was no place for meeting other than a road nearby without electric facilities, the meeting was conducted using headlight of car. A total of seventeen Santal tribal people attended the meeting. Out of seventeen participants, 9 were female and 8 were male. There is an IUGIP under construction road within less than one kilometer from this area. Out of these eleven households, five households follow Hindu religious culture; four households follow Christian religious culture and the two households follow Santal tribal religious culture.

30. The santal people who participated mainly work at agricultural fields as labourers. Both the male and female Santals work in this sector. Their food habit is almost like the mainstream people. They have a leader. All the grievances are settled through their local people.

31. The Santal people stated they have water and sanitation problem. IUGIP has program under LINIC program on extending water and sanitation for the Santal people living here. Duari Uttarpara has formed a LINIC (Low Income Neighborhood Improvement Committee). der Duari Uttar Para is at Ward number 5 of the pourashava. There are three groups under the LIN. This Adivasipara is one the three groups. The pourashava has prepared a Community Action Plan (CAP) for the LIN. The CAP proposed 3 sanitary latrines, 2 tube wells, 1 dustbin , one street light and plantation of 20 saplings for this Santal group lives in Adivasipara.

32. The participants stated in the meeting that there is no adverse impact of the IUGIP works on them. The participants also stated that the TMRESC people will be benefited from IUGIP works. The program will prepare TMRESC Plan if required following the policy principles outlined in ESMF. This SMR contains a specific action plan for the TMRESC.

33. The project is assessed category B for indigenous people/ Tribes, Minor Races, Ethnic Sects and Communities (TMRESC). However, the TMRESC population is scattered around the Pourashavas in almost all the Pourashavas and are well assimilated in the urban society.

34. The participants stated in the consultation that, they will use the IUGIP road after it is completed. The under-construction road is less than one kilometer from their living place. Distance of schools of their children will become short. It can be noted that all of these Santal people can read and write. They also mentioned that due to the proposed road project, their travel time going to town for shopping, access to medical services etc. will be easier, efficient, more comfortable and economic.

G. Concerns of the participants and responses from MDS Consultants

35. During the public participation, the participants exchanged their views with the facilitators. The participants expressed their concerns too. Concerns of the participants of the public consultations are mostly common. Concerns of the participants and responses of facilitators of the public consultations are mentioned in the following table –

H. Consultation Guidelines for TMRESC:

36. The consultation framework is designed to help to ensure that indigenous peoples are well informed, consulted and mobilized to participate in the project works to be implemented under the IUGIP. Their participation will not only make project activities more sustainable but also provide benefits with more certainty, or protect them from any potential adverse impacts of project intervention. The main features/process of the consultation framework includes a social impact assessment to determine the degree and nature of impact supported by the project. An Indigenous Peoples Plan (IPP)/TMRESC Plan will be developed if TMRESC communities are found to be present in or have collective attachment with IP impacts to areas affected under the respective project implementation plan. Consultations with and participation of indigenous peoples, their leaders and local government officials will be an integral part and will be inflected in the overall IP/TMRESC Plan, which should be prepared along with other required project reports.

37. A free, prior, and informed consultation process involving indigenous groups would provide a comprehensive baseline data on social, economic and technical aspects of each investment particularly for those areas that have been identified with ethnic groups during the project screening (preparation). This also includes participatory mapping to determine exact location of construction sites, land size requirement and also location of IP/TMRESC communities. The checklist for screening TMRESC people will indicate whether or not the TMRESC peoples are found in the project area and further identify potential social issues on TMRESC peoples because of the project intervention. IUGIP and Pourashavas will undertake specific measures to consult with, and give opportunity to, indigenous populations to participate in decision making related to the investments, should they so desire.

38. All target areas that have TMRESC people communities and are candidates for project support will be visited (at the time of first consultation with communities) by the Project team including social safeguard, environmental experts and relevant local authorities. Prior to the visit, the TMRESC leaders will be informed that they will be visited by the respective persons and local authorities and that consultation will be conducted to seek support of the project intervention and to determine potential adverse impacts as well as possible support from the project in order to address the potential impact. The notice will request that the communities shall invite to the meeting representatives of TMRESC male and females, village leaders, Organizations deal with TMRESC (NGO) or others as appropriate. During the visit, the community leaders and other participants will present their views with regards to the proposed activities.

39. The focal persons/facilitators will express the Project Grievance Redress Mechanism to the participants and will invite their opinion on the Project GRM. If there is/are conflict/gap between the Project GRM and their traditional cultural mechanism; the gap will be resolved, and gap-filling measures will be identified in consultation with the concerned parties.

40. The IUGIP will also identify and utilize the existing community grievance mechanism to take into account specific cultural attributes as well as traditional-cultural mechanisms for raising and resolving issues— to ensure that the concerns of different ethnic groups are received and addressed during project preparation, implementation and beyond project completion. To achieve this, projects would (a) identify and determine culturally acceptable ways to address grievances from significantly different ethnic groups within affected communities, including different ethnic or cultural groups within the project-affected area; (b) understand cultural attributes, customs, and traditions that may influence or impede their ability to express their grievances, including differences in the roles and responsibilities of subgroups (especially women) and cultural sensitivities and taboos; and (c) agree on the best way to access grievance mechanisms, taking into consideration the ways communities express and deal with grievances.

41. During the visit, the Project safeguard experts or relevant official with social expertise will undertake a screening for indigenous peoples with the help of indigenous people leaders and local authorities. The screening will check for the following:

- (i) Names of ethnic groups in the affected villages/commune;
- (ii) Total number of ethnic groups in the affected villages/commune;
- (iii) Percentage of ethnic people in affected villages/communes; and
- (iv) Number and percentage of ethnic households within a described zone of influence of the proposed investments. (The zone of influence should include all areas in which investments- related benefits and adverse impacts are likely to be relevant.)

42. Once target areas have been selected by the project through screening process and indigenous peoples are identified, a pre-social assessment will be conducted to take note of affected assets (though this would be done in more in the RP/ TMRESC plan, if required to be prepared), baseline socioeconomic survey. Social and economic profile of beneficiary population or project-affected people will be collected. Free, prior and informed consultations will be carried out for each of the beneficiary/affected communities/villages and the respective communes, ascertaining their support and determining the potential impacts and possible support under the Project. The outcome of this process will be the basis to develop safeguard documents as part of the project implementation plan that includes:

- (i) Resettlement Action Plan/TMRESC Plan is to be developed in case private land acquisition and involuntary resettlement impacts/IP impacts are assessed. Outline of social safeguards documents and guideline for preparation is described in the in ESMF; or
- (ii) Due Diligence Report will be prepared if no land acquisition.

43. In case of unanticipated impacts (both on indigenous peoples or land acquisition/involuntary resettlement) occur during project implementation (particularly during construction). corrective actions will be initiated and resettlement plan and/or a combined RP/TMRESC plan will be prepared.

I. DDRs prepared and submitted to PMU during the reporting period:

44. Safeguards due diligence reports are prepared and review to ensure compliance with ADB safeguard policy due diligence requirements. During the reporting period, Resettlement Team visited 23 Packages under 19 Pourashavas for social screening and prepared 23 DDRs. The DDRs are submitted to PMU. PMU includes the DDRs in the Subproject Appraisal Report (SPAR). The list of the DDRs prepared during the reporting period and the cumulative number of prepared DDRs is given below in Table 7.

45. The Project Management, Design and Supervision Consultant (PMDSC) prepared and submitted 47 DDRs up to March 2025. During PPTA period, 119 DDRs were also submitted to PMU. So, in total PMU received 166 (119 + 47) DDRs. A total of 156 DDRs disclosed on the IUGIP website. Out of the 166 packages, the contract have been signed for 133 packages. Out of these 133 awarded packages, civil works have been ongoing for 121 packages. The 156 DDRs are disclosed in the PMU website. The rest 10 DDRs will be disclosed and reported in the next SMR period. (Website link: https://www.iugip-lged.org/document_archive/document.archive.viewer.php)

J. Preparation of Resettlement Plan for IUGIP/CHOW/UT + DR -1 (Chowmuhani)

46. ADB National Consultant and IUGIP Resettlement/Social safeguard Specialist visited Chowmuhani Pourashava on 11 and 12 February 2025. During the visit, involuntary resettlement impacts have been identified at the Bazar Road to Sutkihata Road (IUGIP/CHOW/UT + DR -1). There are at least 50 to 60 floating vendors on the road and drain alignment. During construction works, they will temporarily lose their source of income. In October 2022, only four floating vendors were identified on the drain alignment (IUGIP/CHOW/UT + DR-1), at Bara Bazar Bank (Mosjid) Road, Chowmuhani was reported in a report. But, at that time there was open space in the market to shift them. Now they are 50 to 60 in number. According to the agreed Safeguard Policy of IUGIP, all the affected persons have to be compensated in replacement value.

47. As per IUGIP's ESMF, if the component with identified impacts proposed under the Program, then a resettlement plan (RP) needs to be prepared. In that case, inventory of loss has to be prepared and socioeconomic and census survey will be conducted. IUGIP informed the matter Chowmuhani Pourashava by a letter. IUGIP wanted to know their opinion on preparation of RP. In February 2025, resettlement team of IUGIP visited Chowmuhana and some IR impacts were identified at IUGIP/CHOW/UT + DR-1 package. It was identified that some floating traders will be displaced due to construction work of the drain. The DDR has been revised and drain (D02) was excluded from this DDR. The PMU informed the implementing authority (Chowmuhani pourashava) by a letter that, if they want to continue with the drainage works, a Resettlement Plan (RP) needs to be prepared to address the potential impacts, submitted to ADB for review and clearance prior contract awards of the drainage component. MDSC consultant team will follow up on this.

48. The present condition of the proposed drain can be imagined from the photographs below:

50. Since mobilization at the initial stage, the PMDSC and Social Safeguard Specialists have been working on to finalize the design and preparation of required social safeguard documents/ reports for the identified subproject as well as conducting of feasibility study and worked closely with PMDSC during preparation of final design for the new subprojects selected. During the reporting period, the safeguard consultants subsequently also prepared number of social safeguard reports for subprojects with the design-completed schemes.

51. A list of packages that have been visited and impact assessed by the Social Safeguard Team of PMDSC is appended at Appendix 1. The roads and drains will be constructed within

the rights of way (ROW) of Pourashava roads. Due diligence was conducted to assess the schemes. The assessment indicates that there will be no land acquisition or physical displacement or permanent economic displacement of any individual, household or community.

L. Municipal Facilities

52. The Asian Development Bank (ADB), Agence Française de Développement (AFD) and Government of Bangladesh (GOB) supported Improving Urban Governance and Infrastructure Program (IUGIP) aims to improve infrastructure facilities such as drains, roads, streetlights, low-income neighborhoods improvements (footpaths, drains, streetlights, tube wells, dust bins and community toilets), and market centers and parks in selected 88 pourashavas. IUGIP has already selected seven places to construct or improve markets.

53. It is very important to stimulate economic life in small towns. The presence of a market facilitates the availability of products, create dynamism of production and ensures fair prices of products, creates new employments, increased social communication which is one of the important conditions of development. Up to March 2025 IUGIP has selected seven places in six pourashavas for construction of market centers. All of these seven selected places are pourashava lands and at present there are no running markets. So, there are no case of displacement or loss of income. Construction works are ongoing in two pourashavas. IUGIP has not yet selected any place for park or open space. The following table shows places of markets selected by IUGIP and present status of construction of the markets.

III. INSTITUTIONAL ARRANGEMENTS AND CAPACITY BUILDING

A. Institutional Arrangement for social safeguard

54. The Ministry of Local Government, Rural Development and Cooperatives (MLGRDC) acting through its Local Government Engineering Department (LGED) is the Executing Agency. At the LGED, PMU has been established and this PMU is being supported by the consultants. At the *Pourashava* level, district level team of LGED (PIU) will implement the program related construction works. As part of current RBL program implementation, the PSSA has recommended as an action point for recruitment of one Environmental Safeguard Specialist and one Social Safeguard Specialist at the PMU level. The both safeguard specialists are reporting to the Project Director and together and formed the safeguard cell. At PIU level, one officer of Assistant Engineer rank is designated as safeguard focal person, who will ensure EMP and Resettlement Plan implementation. Project Management, Design and Supervision Consultants (PPMDSC) are engaged to work closely with and advise the PMU and PIUs.

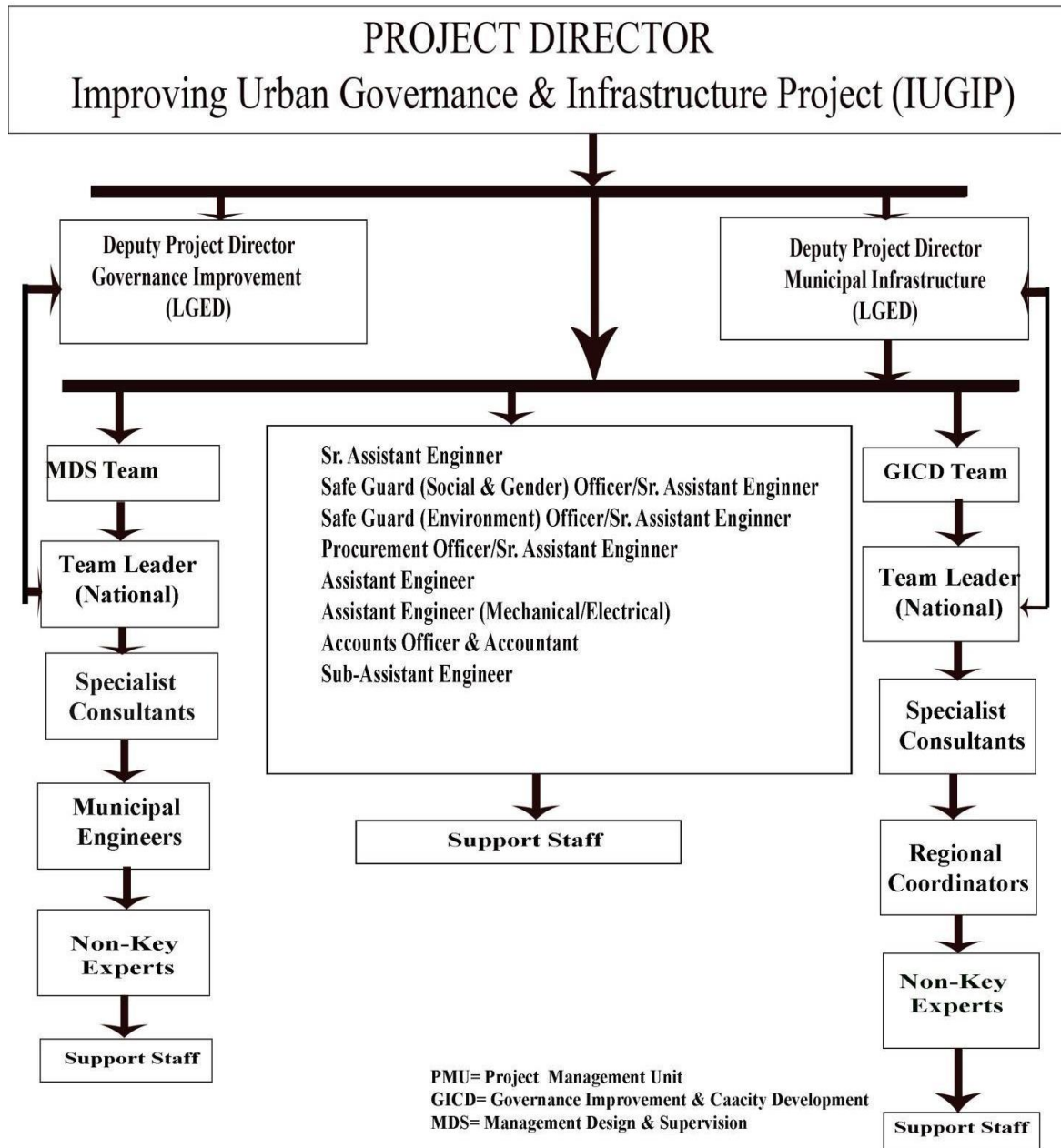
55. Social Safeguard Team of PPMDSC constitutes of Resettlement/ Social Safeguard Specialist and four Junior Resettlement/ Social Safeguard Specialists. Responsibility of Social Safeguard Specialist is to determine requirement of preparation of RP or DDR and to prepare them according to requirement in compliance with ADB SPS 2009 and Regulations of GoB. The team has been confirming inclusion of DDRs in bidding documents and civil work contracts, has been monitoring the implementation and disclosing of social safeguard (DDR)s Plans and Grievance Redress Mechanism. The social safeguard team consolidates monthly social safeguard from PIUs and to prepare and disclose in Semi-annual and Annual Social Safeguard reports upon approval of ADB. PMU Safeguard Cell will assess training need and coordinate training activities for PMU and PIUs officials, Contractors.

B. Training on Social and Environmental Safeguard and Climate change:

57. A two days training program on Social and Environmental Safeguard and Climate Change was organized by IUGIP at Regional Training Center of LGED, Dhaka Head Quarter. The training was conducted during the period January 5 and 6 of 2025. A total of 22 Participants from 11 Municipalities and 11 participants from Management, Design and Supervision Consultancy Services (MDSC) working at 11 Pourashavas participated in the program.

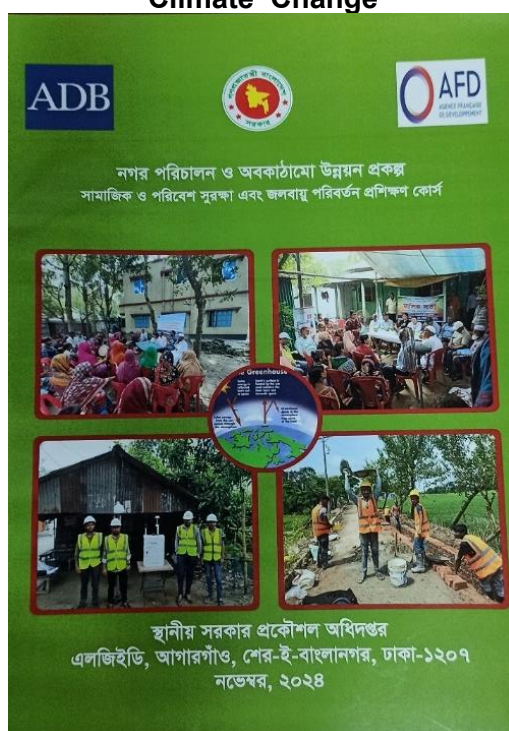


60. A total of 32 participants participated in the training program from 11 Pourashavas. Out of these 32 participants, 11 were Municipal Engineers appointed by MDSC at Pourashava level.

61. The MDSC consultants prepared training materials on their concern discipline. A Training Manual was prepared containing the papers prepared by the consultants. The Training Manual was reviewed by the LGED experts.

62. The following papers on social safeguard were discussed with PowerPoint presentation in the two days program.

- (i) Involuntary Resettlement Policy of ADB;
- (ii) Meaningful Consultation: conditions and practices;
- (iii) Grievance Redress Mechanism of IUGIP;
- (iv) Methods of Land Acquisition;
- (v) Negotiated Settlement and Donation of Land; and
- (vi) Quarterly Monitoring report on IUGIP works from Pourashavas.

63. A Pre training test and a Post training test was arranged for the participants. Both the tests were on 50 numbers each.

64. The trainers of the course were from the experienced LGED Officials, MDS and GICD Consultants of IUGIP. The trainers discussed on subjects selected for the training course. The trainers also use PowerPoint presentations in support of their discussions. List of the trainers is given below:

67. A total of 32 participant attended the training program from 11 Pourashavas. One participant from Araihasar Pourashava could not appear the training program as he was attending in another training program started earlier.

68. To assess the level of knowledge of the participants before and after receiving the training, a pre and posttraining tests were conducted. Separate questions were used for the Pre-training test and post-training test. The participants scored 50.46% and 77.66% in Pre-training test and post-training test respectively.

69. The training program was ended on the second day at 5 pm. Project Director, IUGIP

presided over the closing session of the training program. The Project Director in his closing speech asked the participants to apply their earned knowledge from the training in their practice.

IV. GRIEVANCE REDRESS MECHANISM (GRM)

70. In order to receive and facilitate the resolution of affected people's concerns, complaints, and grievances concerning the subproject's safeguards performance, IUGIP has established a Grievance Redress Mechanism (GRM) consistent with the ESMF. This GRM will work to address any complaints related to project activities that arise during the implementation of the subproject. The RBL program have both online as well as offline mode to receive the grievances. An aggrieved person can register his/her complaint through telephone, mobile, or email or by writing in the Complaint Registers maintaining in the PIU/*Pourashava* office and contractor's offices.

71. Complaint boxes are installed at the PIUs. The safeguard focal person at PMU will ensure the follow-up of the grievance until resolved. The PMU will have a regular review to ensure that all grievances are resolved in time-bound and through a transparent mechanism. The affected person is free to access the country's legal system at any time and at any stage. The affected person also can use the ADB Accountability Mechanism (AM) through directly contacting (in writing) the Complaint Receiving Officer (CRO) at ADB headquarters or the ADB Bangladesh Resident Mission (BRM). The sample of Grievance Registration Form has been appended in Appendix- 4. The registration form used in ESMF has been revised following the requirement and the English version of the form annexed in this report. PMU safeguard officer will have the overall responsibility for timely grievance redressal on environmental and social safeguards issues and for registration of grievances, related disclosure, and communication with the suggested party through the PIU designated safeguard focal person.

72. The GRCs are using grievance redress registers to maintain the records of complaints and of resolution of complaints. The grievance redress registers recorded the summary of the complaints, hearing processes of complaints, GRC decision and opinion of the complainants. A guideline to operate GRM, sample of grievance registration form and model/format of grievance registers will be prepared in Bengali and will be shared to all of the project *Pourashavas* for their uses.

73. The multi-tier GRM for the project is outlined below. Time-bound schedules of each tier discussed and persons responsible for arranging hearing and redressing the complaints are also identified.

74. **1st Level Grievance, Pourashava Level PIU.** The contractors, PIU Safeguard and Gender Focal person can immediately resolve issues on-site or at *Pourashava* level in consultation with each other with the support of Administrative Officer of *Pourashava*, designated municipal ward councilor and will be required to do so within 7 days of receipt of a complaint/grievance. Assistance of ward committees (WC) will be sought if required for resolution of the issue, by any one or all of them jointly. The First Level Grievance Redress Committee will be comprised of the following members:

- (i) Chief Executive Officer or Paura Nirbahi Officer
- (ii) Executive Engineer, *Pourashava*/ Safeguard and Gender Focal person
- (iii) Administrative Officer, *Pourashava* (will act as secretary GRC level-1)
- (iv) Municipal Ward Councilor (designated)/ WC member
- (v) Medical Officer/Environment Health Safety (EHS Supervisor)/, Contractor
- (vi) Affected Person's Representative/ Community or NGO Representative of

project Area.

(Some designation of the members of GRC required to be changed in ESMF)

75. **2nd Level Grievance, Pourashava Level.** All grievances that cannot be redressed within 7 days at Ward level will be brought up to the Second Level Grievance Redress Committee (GRC) headed by the Panel Mayor. Second Level Grievance Redress Committee at Pourashava level will attempt to resolve the grievance /complaint within 15 days. The composition of 2nd level Grievance Redress Committee is as follows:

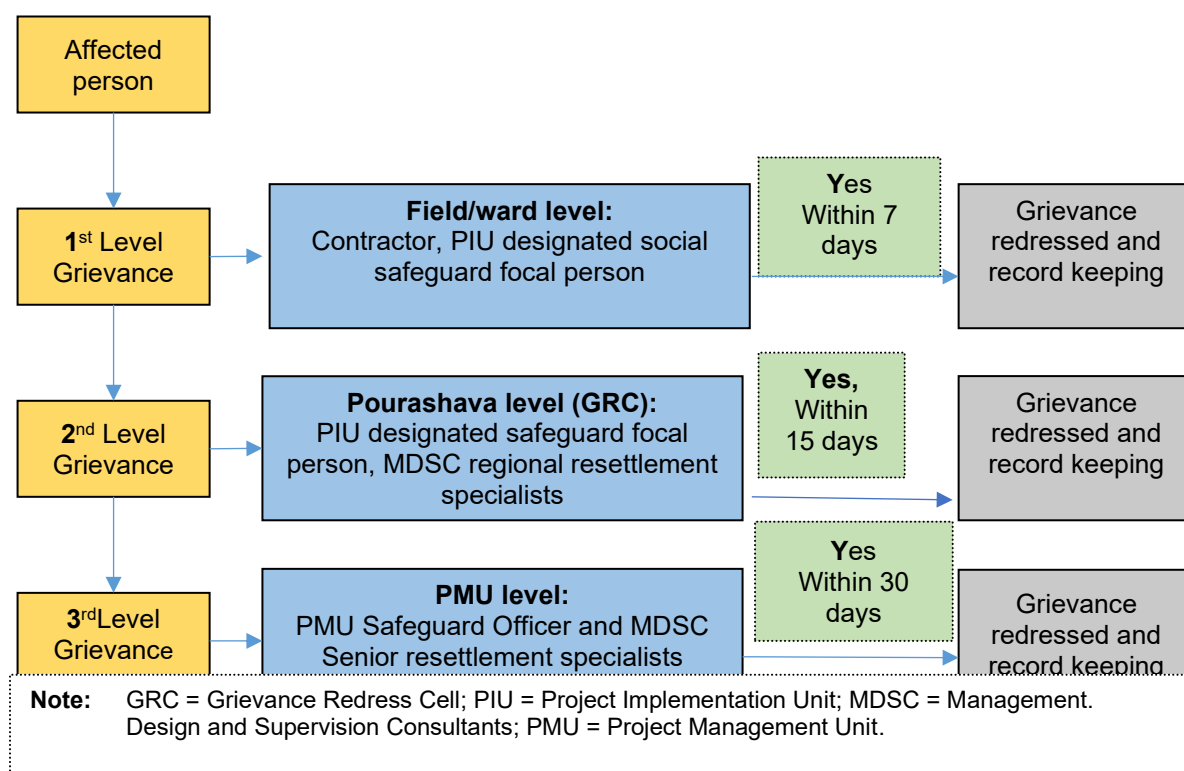
- (i) Panel Mayor of the Pourashava
- (ii) Chief Executive Officer/ Poura Nirbahi Officer (will act as member secretary)
- (iii) Executive Engineer of the Pourashava
- (iv) Concerned Councilor of the Pourashava
- (v) Administrative officer of the Pourashava
- (vi) One women member/ Reserve women seat councilor
- (vii) Representative of Affected Person/ TLCC member/ NGO member.

76. **3rd Level Grievance, Project Management Unit (PMU):** The grievances that are not redressed within 30 days of submission at Pourashava level will be forwarded to the PMU level. Pourashava Level Grievance Redress Committee will refer any unresolved or major issues to the PMU level Grievance Redress Committee, which will be headed by the Project Director and will have Mayor of the Pourashava, Deputy Project Director, Senior Assistant Engineer, Resettlement/ Social Safeguard Specialist, Environment Specialist as Committee Members. The 3rd Level Grievance Redress Committee will resolve the complaints/grievances within 30 days of receiving. The 3rd Level/ PMU level Grievance Redress Committee will comprise of:

- (i) Project Director,
- (ii) Mayor of the Pourashava
- (iii) Deputy Project Director
- (iv) Senior Assistant Engineer (will act as Member Secretary GRC level-3)
- (v) Resettlement/ Social Safeguard Specialist
- (vi) Environmental Specialist
- (vii) Senior Assistant Engineer / Gender Focal Persons

77. After August 2024 position of Mayors and Counselors are abolished. Government deployed Administrators for the position of Mayor. So, the Administrators are replaced in place of Mayor in GRCs and Representatives of Executive will be replaced in position of Councilor in GRCs.

78. After August 2024, positions of Mayors and Counselors are abolished. The government deployed Administrators for the position of Mayors. The Administrators are replaced in place of Mayor in GRCs. This is a temporary arrangement for interim period.

79. During the reporting period, 10 Pourashavas under the program have received 47 complaints. Most of the complaints were related to disturbance from construction works. GRCs alerted authorities related with the construction works and the complaints were resolved with good construction practices. The complaints are recorded in the complaint registers of GRCs. The list of the complaints received and resolved by GRCs is given below.

80. Out of the 47-complaint received by the GRCs, 46 are resolved. One complaint remains unresolved at Gangni Pourashava. The GRCs in 10 Pourashavas received 47

complaints during the reporting period and resolved 46 complaints. One complaint received by Gangni pourashava remained as unresolved/pending for resolution. The complainant stated in his complaint that, he is a beneficiary of the proposed park at Gangni. But few people are disturbing in construction of the park for their personal interest. As a result, construction work is delaying. So, the complainant requested to take necessary action in this regard and complete the construction of the park as early as possible. The pourashava informed the matter to Gangni Police station and submitted a complaint as General Diary (GD). The Upazila Nirabahi Officer UNO (Sub-district Executive Officer) who is also Administrator of Pourashava was also informed the matter. He assures that the matter will be settled soon.

81. The project beneficiaries of 53 pourashavas have not reported any problems from construction works. GRCs of these pourashas have not registered any complaint during the reporting period. PMU has a plan to provide training for the pourashava level staffs of PMU and PIU of 63 Pourashavas on social and environmental safeguard by June 2025. PMU already arranged the training program for 33 field level staffs from 11 pourashavas.

V. REPORT ON REVIEW MISSION OF ADB AND AFD (11 – 17 DECEMBER 2024)

82. The Asian Development Bank (ADB) conducted a Review Mission on IUGIP through a combination of Stakeholder meeting, field level meeting and site visits. The Mission aimed to:

- (i) Review the progresses, compliance and due diligence of ongoing work and services;
- (ii) Meet the relevant stakeholders including the Project Management Unit (PMU) of IUGIP, Implementing Agencies from the pourashavas, contractors, consultants and communities.

83. The Mission hold a Meeting at LGED Headquarter Auditorium on 11 December with the relevant stakeholders including the Project Management Unit (PMU) of IUGIP and consultants. The Mission was headed by Mr. Amit Datta Roy, Senior Project Officer and Co-Mission Leader, Mr. Rafiul Islam, Project Officer, Agence Francaise de Développement (AFD), Mr. Saifullah Dostogir, Social Safeguard Consultant, ADB and MR. Rezaul Hoque Khan, Environment Safeguard Consultant, ADB – physically attended the meeting. While Mr. Kyaw Thu, Senior Urban Development Specialist, Mission Leader attended the meeting virtually.

84. The Chief Engineer and Additional Chief Engineers of LGED, Project Director and Deputy Project Director of IUGIP, Team Leader of Management Design and Supervision (MDS) Consultancy and Team Leader of Governance Improvement and Capacity Development Consultance Services (GICD), Resettlement / Social Safeguard Specialist and Environment Specialist from MDSC and consultants from GICD and others attended the meeting.

85. Objectives of the Mission was to:

- (i) review the progress of the outputs and the DLIs included under the program;
- (ii) discuss major and long-standing issues;
- (iii) review the safeguards and compliances; and
- (iv) prepare a timebound action plan for resolving the issues.

86. Mr. Kyaw Thu, Mission Leader joined the Mission virtually and discussed on project management, compliance, safeguards, procurement and other necessary due diligence. The Mission Leader also reviewed Disbursement Linked Indicator (DLI) and current work progress.

87. Mr. Amit Datta Roy, Co-Mission Leader and Co-Team Leader, IUGIP attended the Mission physically. Mr. Datta discussed on the key challenges in project management, safeguards, procurement and other necessary areas. The mission reviewed site and current work progress under IUGIP.

88. The Project Director presented the project activities, progress and challenges. The Resettlement/ Social Safeguard Specialist and Environmental Specialist informed the mission ongoing and potential social and environmental activities of IUGIP. The Resettlement Specialist presented the social safeguard activities of the project using power point presentation. The expert responded on different queries of the mission members.

89. The Mission members visited Noria and Kaligonj pourashavas on 13 and 15 December respectively. Project Director, Team Leaders of Management, Design and Supervision consultancy (MDSC), Team Leader of GICD, Senior Officials and Senior Consultants were along with the Team Members during the Mission. 90. The Mission Members monitored the ongoing works of IUGIP.
91. At the end of the Mission, the Mission Members met with the IUGIP senior personnels in a wrap-up meeting.

VI. FOLLOW UP ACTIONS, RECOMMENDATION AND DISCLOSURE

92. In most of the Pourashavas, Project implementation works of IUGIP is ongoing. In these subprojects, social safeguard compliances have been considered with importance. During preparation of design for the subprojects, social safeguard impacts are screened, identification of avoidance and mitigation measures and to determine requirement of preparation resettlement plan or due diligence report.

93. The baseline data are available from social screening report, PSSA report and due diligence reports. The social safeguard team had visited the construction works to monitor how the social safeguard requirements are addressed and complied during construction works. During the monitoring, the Assistant Engineer from pourashava and monitoring engineer of PMDSC assist the social safeguard team of PMDSC in monitoring. The monitoring team uses the prescribed monitoring checklists at fields.

94. The team works on construction work ongoing places, workers shed and meet community people. Monitoring reports are prepared based on this observation too. The data will be used in measuring the social safeguard progress.

A. Mitigation of Impacts and Grievances

95. IUGIP aims at enhancing urban governance and improving infrastructure sustainability of the targeted Pourashavas using an approach based on integrated and holistic planning. The Project supports the development of key urban infrastructure, focusing on projects that enhance the urban environment, poverty alleviation, gender responsive and economic development. The Project also supports the Government to strengthen Pourashavas management and capacity for effective and sustainable urban development.

96. Program will prepare Resettlement Plan in case of requirement of Involuntary Resettlement. While there are no significant or no IR impacts and impacts are of short term and can easily be mitigated project prepares Due Diligence Report. It has been reported in the PSSA that, "The roads and drains will be constructed within the rights of way (ROW) of Pourashava roads, and low-income neighborhoods improvement works, markets and parks will be undertaken on Pourashava land. Initial assessment indicates that there will be no land acquisition, or physical displacement or permanent economic displacement of any individual, household, or community." PSSA consultants assessed social safeguard impacts as the "Baseline features on proposed roads, and drains" in the sample five Pourashavas. It was reported the RBL program activities are unlikely to have significant adverse impacts. The potential impacts are short term and can easily be mitigated. Though it was mentioned in "Baseline features" of few roads of Chowmohani and Naohata there are few trees in the RoWs. But during visit of the social safeguard team in 2024, no trees were found in the RoWs in the Pourashavas. The team discussed with the community people about the reported trees. No claimants or private owners of any trees were reported. All the affected trees were under Pourashava ownership. The program has plantation policy to plant multiple numbers of saplings at the under-construction roadside in place of an affected tree.

97. During visits of social safeguard team local people raised some problems due to construction works which required immediate solutions to avoid losses/ difficulties of the affected people. So, the team had to solve the problems, on the spot, and in each case, the affected persons expressed their satisfaction with the solution provided. The required corrective actions by the contractors were followed up by the safeguard team and ensured; some examples are provided below:

98. During visit to R 158 of Naohata, it was found that earthwork was ongoing for construction of a culvert. Contractor arranged an alternative road for moving people and transports. But the alternative road was not smooth enough and there were no alerting red flags and signboards. It was tough and risky for moving people and transport through this temporary and alternative road. Contractor was advised to improve the alternative road, use alerting flags, signboards and make it more convenient for people and vehicular transport.

99. Rectification works were undertaken by the contractor and the next day, when the team visited the spot again, the road condition was found to be more convenient for movement. It was found that the contractor had engaged labor to level the road, doing earth filling works and erected red flags and alerting signboards.

100. The team also visited Bhabanigonj Pourashava from November 19 to 21 of 2024. During this visit, social safeguard impacts were assessed. The team visited 8 schemes under the Pourashava. During the visit to D-21 it was found that the area is densely populated and the under construction drain of IUGIP was being used as road by the local people. The team found there were no covers on the completed portion of the drain. It was risky for movement, especially for children.

101. On the spot, the issue was addressed, considering the risks to local people and to avoid accidents. The problem was not placed to GRC, but it was informed to PIU.

102. Contractors were advised to cover the manholes immediately with temporary covers and keep them up to fixing the final covers. Next day, the team visited the same area and conducted a public consultation with the local people and found the manholes were covered with MS sheets as temporary covers. The final covers were subsequently fixed within a short period.

103. During monitoring of safeguard issues at Raozan, it was found that contractors stacked stone chips at Package UT +DR 02 without keeping space for movement. Local people could not use the road for this stone stack. The contractor was called and advised to remove the stone chips from the road and stack them following the contract agreement. The contractor removed the stone chips from the road without delay.

C. Future Programs for the next Reporting Period:

104. Future activities planned for the next SMR period (April 2025 to September 2025)

- (i) Social screening will be completed for the packages which will be proposed during the period.
- (ii) Social safeguard monitoring will be done for the construction works ongoing packages.
- (iii) Training on Social and environmental safeguard and Climate change will be arranged in five Regional Training Centers of LGED. Expecting 156 participants will attend in this program from 52 pourashavas by June 2025. A total of 33 participants from 11 pourashavas already trained on Social and environmental safeguard and Climate change in January 2025.
- (iv) Continuous meaningful consultations will be undertaken with stakeholders.
